PARENT LESSON AND TUITION AGREEMENT/REGISTRATION FORM

Music in Catholic Schools (MCS) provides band classes during the school day to students in grades 5-8 in Omaha parochial schools. All staff members of the program are certified music teachers in the state of Nebraska. The Superintendent of Schools, Omaha Archdiocese, is the Executive Director.

Attending band classes, regular practice at home, participating in band activities, and your cooperation in supporting and encouraging him or her are necessary for musical growth. Your son or daughter is obligated to enroll in Music in Catholic Schools at least one semester to have a successful experience (though a full school year is much better.) Parent(s) must agree to enroll the student(s) named below for a minimum of one-half school year (one semester), and will be obliged financially to pay for a minimum of one semester of band tuition. The teacher will make written evaluations so parents can understand their student's progress and potential to determine whether or not the student should continue band classes.

Termination of band classes can occur only after the minimum period of instruction (one half school year or one semester) and receipt of a written drop notice that is signed by a parent. No tuition refunds are made for classes missed before this time. **Parents are obligated to pay for a minimum of one-half school year (one semester.)**

Tuition for band classes is based on the regular school year, including all scheduled school holidays. This tuition is for teaching services and does not include instrument rental.

Tuition for band classes and music fees for a single student for the nine-month school year is \$540. Family tuition for two or more students is \$765 for the school year. Annual fees may be paid at registration, or parents may pay the first month's payment (\$60 for a single student or \$85 for two or more students) and pay the remainder via automatic monthly transfer of funds (ACH). The corresponding portion of this form must be completed and signed for automatic or credit card payments to occur.

Special tuition rates are for students on free and reduced lunch. Those on reduced lunch -- \$315 per year per student (\$35 per month ACH.) Those on free lunch -- \$225 per year per student (\$25 per month ACH)
