TO OUR VENERABLE BROTHER **GEORGE JOSEPH LUCAS**, UNTIL NOW BISHOP OF SPRINGFIELD IN ILLINOIS, TRANSFERRED TO THE ARCHDIOCESE OF OMAHA, GREETINGS AND APOSTOLIC BLESSING.

AS SUCCESSOR OF BLESSED PETER AND FATHER OF THE LORD'S ENTIRE FAMILY, WE EARNESTLY DESIRE TO PROVIDE APPROPRIATELY FOR THE METROPOLITAN CHURCH OF OMAHA, WHICH IS VACANT OWING TO THE REIGNATION OF HIS EXCELLENCY THE MOST REVEREND ELDEN FRANCIS CURTISS. ACCORDINGLY, YOU, VENERABLE BROTHER, ENDOWED AS YOU ARE WITH PROVEN QUALITIES OF MIND AND HEART AND MUCH PASTORAL EXPERIENCE, SEEM SUITABLE TO BE ASSIGNED TO IT.

THEREFORE, ACCEPTING THE OPINION OF THE CONGREGATION FOR BISHOPS, BY THE SUPREME APOSTOLIC AUTHORITY, WE RELEASE YOU FROM THE PRIOR BOND OF THE DIOCESE OF SPRINGFIELD IN ILLINOIS, AND WE APPOINT YOU METROPOLITAN ARCHBISHOP OF **OMAHA**, WITH ALL RIGHTS BEING GRANTED AND, LIKEWISE, OBLIGATIONS IMPOSED. INDEED, WE MANDATE THAT THIS LETTER BE BROUGHT TO THE ATTENTION OF YOUR CLERGY AND YOUR PEOPLE; AND WE EXHORT THEM TO ABIDE BY YOU READILY AND TO REMAIN IN COMMUNION WITH YOU ALWAYS.

FINALLY, VENERABLE BROTHER, WITH THE VIRGIN MARY INTERCEDING, WE BESEECH FOR YOU THE CHOICEST GIFTS OF THE PARACLETE SPIRIT: AIDED BY THEM, YOU WILL FULFILL THIS NEW OFFICE OF SHEPHERD BY WORDS AND, ESPECIALLY, BY THE PERSUASIVE ELOQUENCE OF LIFE EXAMPLE, MINDFUL OF THE WELL-KNOWN DICTUM, "WORDS IMPRESS, BUT EXAMPLES PERSUADE."

IN ADDITION, MAY THE PEACE AND LIGHT OF CHRIST BE EVER WITH YOU AND WITH THE ECCLESIAL COMMUNITY OF OMAHA, WHICH IS SO VERY DEAR TO US.

GIVEN AT ROME, AT ST. PETER'S, ON THE THIRD DAY OF THE MONTH OF JUNE, IN THE YEAR OF THE LORD TWO THOUSAND NINE, THE FIFTH OF OUR PONTIFICATE.
